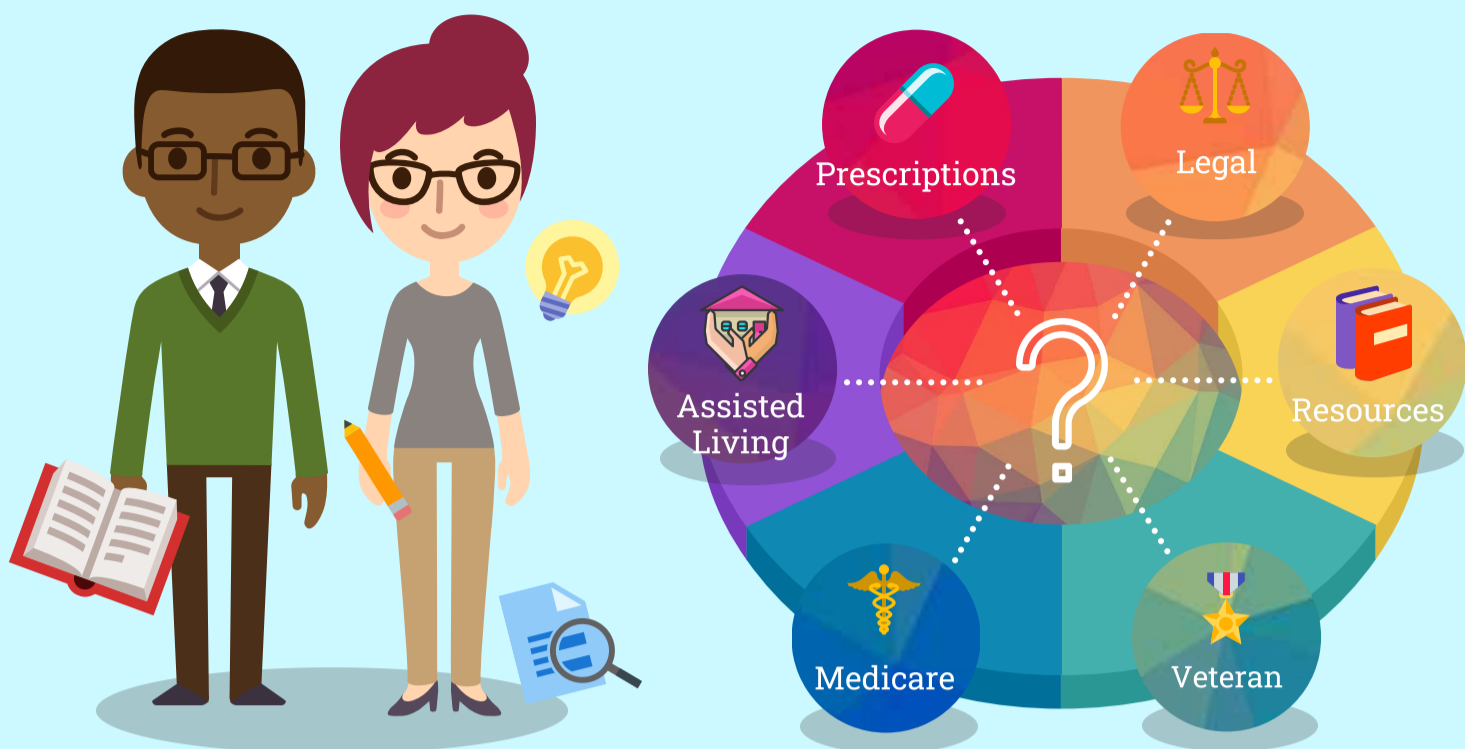


Understanding Caregiver Support
